Internet Service For Records in Scotland

The General Register Office for Scotland has announced that Internet service will be formally launched by Henry McLeish, Minister of State, at the Scottish Office on Monday, April 6th. Public access to the database will be available immediately after the launch. The service will provide WWW access to a fully searchable index to births/baptisms and banns/marriages from the Old Parish Registers dating from 1553-1854, and births, marriages and deaths from the Statutory Index for 1855-1897. An index to the 1891 census will also be provided (the 1881 census data will be available later this year.) Charging for the service will be by credit card and charges will be similar to those currently charged by the GRO(S) at New Register House in Edinburgh. IGI ADDENDUM The new IGI Addendum has arrived. There are now 17 Addendum CD'S - 10 more than the old edition, with 41.6 million more names than the old IGI Addendum for a total of 84 million names. The new emphasis of the IGI is as a research tool and it no longer shows LDS Ordinances. There is a new LDS Option to look for Ordinances.

ANCESTRAL FILE The Ancestral File program now allows descendency charts to be downloaded as GEDCOM files and the submitters list now appears in alphabetical order. There has not been an update to the actual database.

FAMILY HISTORY LIBRARY CATALOGUE You can now search for a specific topic in the locality search, i.e. a specific church name or other particular type of record.

TEMPLE READY Individuals and couples now only appear once in a report and dates will no longer be estimated beyond one generation from what is known. The new Temple Ready will not accept PAF 2.0 files, only PAF 2.1 or higher.

RESEARCH OUTLINES All of the U.S. states and several of the foreign country Research Outlines have been revised. These have been filed in the Research Outline binders on the counter along with the revised Genealogy Word Lists for foreign countries, Letter Writing Guides, and new list of Accredited Genealogists. PARISH AND VITAL RECORDS A new edition has been filed in the microfiche drawer.

NEW MICROFILM READERS The two new film readers in the back room are finally ready for use!

LOT AND LAND BOOKS AT MISSOULA COUNTY

The Records Management Department recently found some lot and land books in the Records Center and moved the books to the office. There are three (3) books for platted SUBDIVISIONS; and five (5) books for land listed by SECTION, TOWNSHIP, AND RANGE. Sometimes called BLIND BOOKS by the Title

Companies, they show only the Book and Page numbers for documents recorded pertaining to a specific piece of land. There are no dates in the books, however, Declaration of Occupancy's, some of the earliest land records, are shown. Dating of these instruments would be accomplished by looking at the document the Book and Page refers to for each piece of land. It is not known when the use of these books was discontinued, but it appears they go into the 1930's.

The Book and Page numbers refer to different types of documents; some shown in different colors of ink. Examples of the types of documents included in these books are:

Lis Pendens Agreements Articles of Incorporation Miscellaneous Attachments Mortgages Chattel Mortgages Order & Decrees Contracts **Placers** Deeds Power of Attorney **Declarations of Occupancy** Sheriff Certificates of Sale Easements Tax Deed Affidavits Leases Vacations - Street & Allev Liens Water Rights

The SUBDIVISION BOOKS show the Bk. & Pg. for the Lots & Blocks they address in the subdivision. The SECTION, TOWNSHIP, RANGE books show the Bk. & Pg. for the quarter section they address in each section, by Township and Range.

The information in these books could be very helpful if trying to track the early history of your piece of property, by the **legal description**.

The Records Management office also has microfilmed the early Lot Books, Land Books, and Sanborn Map Book from the Assessors Office. These also trace ownership by legal description, showing the Bk. and Pg. numbers and ownership names. The Records Management Office is located in the basement of the Missoula County, Courthouse, 200 W. Broadway, Missoula, MT 59802.

SOUNDEX COMPLEXITIES - THE LETTERS W & H

What do you do with 'h' and 'w' when you are trying to Soundex Code a name? This has been a subject of concern lately as evidenced by several recent postings to the Newsgroup soc.genealogy.computing. One person wrote that "The written rules I saw at NARA say " If the letters are separated by a vowel they are coded separately. If they are together or separated by an 'h' or 'w' they are

adjacent and are coded once."" Another writer said that "All the published NA materials on the subject that I've seen, the latest probably being General Information leaflet 55, "Using the Census Soundex", published 1995, make no mention of the 'h' or 'w' hidden rules (they simply say that the 'h' and 'w' are not coded.") In his book "The Researcher's Guide To American Genealogy", p175, Val Greenwood says that "No code is assigned to a. e. j. o.u. y. w., or h. And whenever two letters with the same code number are in immediate sequence (my emphasis) the two are coded as one letter."

The problem seems to be: Did the soundex coders of the 1930's treat the 'h' and 'w' as a separator as the vowels a, e, i, o, u and the letter y are treated, or were the 'h' and 'w' simple ignored as if they were not there at all? -It was also said that "when questioned by two volunteers, NARA declined responsibility and knowledge of this new wrinkle, having not heard it until these two persons inquired."

Here are some examples of Soundex coding using the two different methods of treating 'h' and 'w':

NAME	SEPARATOR 'h'	IGNORE 'h'
ASHCROFT	ASHCROFT = A226	ASCROFT = A261
KATSCHKE	KATSCHKE = K322	KATSCKE = K320
DEMSHKI	DEMSHKI = D522	DEMSKI = D520
WITSCHGER	WITSCHGER = W322	WITSCGER =W326

In the first three cases listed the name was actually found in the Soundex under the 'ignore h' Soundex code. The last name (WITSCHGER) is one of mine that I have not been able to find under W322. I intend to go back and look under W326! Since ASHCROFT was found as A261 in every Soundex (1880, 1900, 1920) it would seem that all of the Soundex may have been coded using the 'ignore h' rule, and possible 'ignore w' as well, although the later has not been documented.

From the above it looks like the rule to apply to Census Soundex coding is: If the letters are separated by a vowel, they are coded separately. If they are together or separated by an 'h' or 'w' they are coded once. Certainly, to be sure, code and check names using both coding methods. Also note that the Passenger Arrival Lists Soundex and the Social Security Death Index Soundex are note coded like the census - they use the 'separator' method.

The freeware Soundex Coder program mentioned in Bits & Bytes has been updated to include both of these Soundex coding methods. It runs in windows and is 240KB.

MONTANA STATE GENEALOGICAL SOCIETY

The Montana State Genealogical Society Executive Board is submitting and recommending the following changes to the Montana State Genealogical Society Bylaws. The executive board approved the presentation of the changes at the quarterly meeting on February 7, 1998 in Helena, Montana. The membership will act on these proposed changes during the Annual Conference, May 1-2, 1998 in Missoula, Montana according to the following Article of the current Bylaws:

ARTICLE XIV: AMENDMENTS

These Bylaws may be amended at the Annual Meeting by a two thirds (2/3) vote of qualified members present and voting, using the following procedure:

- Proposals may be submitted by any member to the Executive Board at least sixty (60) days prior to the Annual Meeting.
- All such proposed amendments, together with the recommendations of the
 Executive Board, shall be presented in writing, to the membership at least one
 (1) month prior to the Annual Meeting.

Additions to the Bylaws are underlined and will be added to the Bylaws if passed by the members in Missoula. Those words that are struck through will be deleted from the Bylaws. The proposed changes to the Standing Rules are for your information. The Executive Board would appreciate any feedback from the members before they take action on these proposals. Rationale: The Board discussed the need for providing another avenue to membership in the MSGS.

15. All Life Members shall be given a certificate indicating their life member status. This is the responsibility of the Registrar. Life membership money shall be placed in an interest bearing account, and the interest used for the general fund when needed.

Rationale: Relates to the recognition of the Life Membership Status and the use of the revenue derived from the membership.

16. No one person may cast more than one vote. No proxy vote is permissible; voters must be present to vote. Rationale: Voting should be done by those present at the appropriate meetings.

Proposed Changes to the Montana State Genealogical Society Bylaws February 7, 1998

ARTICLE X:

MEETINGS

SECTION 1:

The fiscal year for the Society

a. The fiscal year of the Society shall be from July 1 of the one year through June 30 of the succeeding year.

b. For accounting purposes, the books of the Society shall be closed on March 30 of each year, and the Treasurer shall present a financial statement as of that date to the members at the Annual Meeting.

Rationale: The proposed change here would provide time for the Treasurer to close the books and prepare a financial statement for the members at the Annual Conference. Prior to this time the financial statement was after the Annual Conference and not widely publicized.

ARTICLE VI:

DUTIES OF THE OFFICERS

SECTION 5:

The Treasurer shall be bonded and shall have custody of the funds of the Society; shall deposit them in insured institutions or invest them pursuant to Executive Board policy; shall make disbursements as directed by the Executive Board; and shall be responsible for the collection of all dues, fees, and debts owing to the Society. The annual report of the Treasurer shall be audited at the close of each fiscal year and the report as audited shall be distributed to the membership. It is the responsibility of the Executive Board to select a person or persons to audit the Treasurer's Report.

Rationale: This change would delete the bonding of the Treasurer. The process of Bonding is expensive and with the limited budget of the Society it has not been done in prior years. We elect people with integrity and therefore Bonding is not necessary.

ARTICLE VIII:

COMMITTEES

SECTION 1:

The names and purposes of the Society Standing Committees shall be as follows:

a. AUDIT - to audit the Treasurer's Annual report at the close of each fiscal accounting year. The Audit Committee shall consist of three members. The Audit Committee shall submit a written report to the Executive Board present an oral report to the members at the Annual Business Meeting, and publish this report in the Society newsletter.

Rationale: With the change in the Accounting year it is now possible to present an oral report to the members at the Annual Conference.

ARTICLE V:

OFFICERS

SECTION 1:

The elected officers shall consist of the President, the First Vice President, the Second Vice

President, the Secretary, the Treasurer, the Registrar, and the Immediate Past President (by virtue

of the office)

SECTION 2:

Officers shall be elected for a two (2) year term and may serve the Society for one (1) consecutive term (maximum four (4) years total), using the procedures of the Nominating Committee and shall

take office at the first board meeting after the State Conference.

SECTION 3:

A vacancy in any elective position shall be filled by the Executive Board until the next election.

SECTION 4: All elected officers shall be residents of the State of Montana during the term of their office.

Rationale: The new Section is to maximize the accessibility of the officers in the State during their term of office.

ARTICLE VIII:

COMMITTEES

SECTION 1:

The names and purposes of the Society Standing Committees shall be as follows:

h. AWARDS - to develop the Society's award program including the Anna Mae Hanson Award, to establish the selection process for all awards presented by the Society, and to screen and select all awards presented by the Society. The Second Vice President shall be a member of the Committee. The Awards Committee shall consist of three members.

Rationale: The addition of the Awards Committee will provide an opportunity to present awards to the members that so richly deserve the recognition in an organized manner.


