- A year ago I began entering data onto PAF. I am a novice.
  It has helped me be more organized. Probably have another 10 % to get typed in yet.
- Virtually all of my relative genealogy is on computer, although much of it could be reorganized and edited.
- 95% is on my computer, but not in any formal family tree software. I would like to get it entered into a formal software package.
- About half is on computer it

would be good to have all of it on. I'd like to have an actual pedigree chart to print, instead of just have Ancestry, which doesn't print those charts really well.

- Right now none. I don't trust my computer ---eventually when I get more ambitious, I might consider getting all my information into a computer.

  - 75% of my research is computerized; I use Family Tree Maker 2009. I would like to have it all on the computer. I keep a backup in a fire proof

**Digested Summary of Private Claims** 1853-1882 — [From Footnote.com] Almost half of the laws passed by Congress have been private acts applying to a single person or a specified group of people... While the bulk of the claims were for pensions, arrears of pay or compensation for property taken or destroved, land claims ran a close second... The text is fully searchable and the search engine searches across all five volumes simultaneously... Many of these claims never became law, but even if they didn't they generated paper-paper that provides details about our ancestors. This index is the first step in getting to the additional paperwork found in the records of the House of Representatives' Claims Committees [NARA Record Group 233].

Need information on all of these people. James Thomas Case (1861 MO—1951 Missoula.) He was employed at the Anaconda Copper Smelter; Died in Missoula but buried in Anaconda. He married his second wife, May Hollenbeck, in Anaconda; the marriage seems to have been short lived. His third wife was Ida Carey who died in 1928 in Anaconda. She had been a nurse at the Anaconda Hospital for many years. I am descended from the first wife whom he married in MO. Want to hear from anyone who may have information on any of these people.

box, because you can never be too careful with these things.

- About 50 %. I'd like it all saved digitally.
- I use Family Tree Maker and so most of my stuff is on the computer.
- I would like to spend a lot more, but life has other plans
- A Family Tree Maker database holds basis statistics. Photographs, document copies, handwritten notes, etc., etc., are not computerized.
- About 10% is on the computer and I am working to computerize it. 100% of the photos are on the computer (and backed up by a commercial firm twice daily). I now have way over 1000 photos (some back to the Civil War, and some recent), and I am using Photo Shop to work on the photos.
- All of my family group sheets are on my computer. I am working on transcribing my obit. collection, etc.
- 97%, probably. I'd like it all there. (Including, of course, the facts that I can't find!)
- .00001%, I have the program and I am entered.
- 2%. I had more but between moving computers I lost most of it.
- About 50 % on the computer. I would like it all, but I'm too lazy.
